If there are different contacts for various departments, please provide the relevant contact information for each.**
  - **If the Trust utilises NHS Professionals (NHSP) or an equivalent master vendor/neutral vendor, please include the contact details (name, job title, email address, and phone number) of the individual(s) responsible for onboarding third-party suppliers to the Trust via these vendors.**
- 2. Process for Applying to the PSL for temporary nursing:**
  - **Information on the process, criteria, and requirements for clinical agency suppliers to be considered and added to the NHS Trust's Preferred Suppliers List.**
- 3. Which Clinical Agency Staffing Framework is being used by the Trust for nursing? E.g RM6281/THE.**
