Thank you for your request for information received on the 17th June 2024. We can confirm that the Staffordshire and Stoke-on-Trent Integrated Care Board can provide the following information.

Please see our responses in blue below:

We understand that numbers will vary from month to month so we are requesting the total number of laptop computers (not desktop computers) used within the Staffordshire and Stoke-on-Trent NHS system as of the nearest last count for 2024?

The number of laptops issued by Staffordshire and Stoke-on-Trent ICB which are currently in active use is 2,355. This number includes laptops currently in active use within both Primary Care and by ICB corporate staff. The vast majority of these were laptops provided for GP Practices and not the ICB (who only have a maximum of 300 staff).

Please note this response is only for the assets issued by the Staffordshire and Stoke-on-Trent ICB and does not cover the whole of the Staffordshire and Stoke-on-Trent NHS system.
